## Notes on Price Guide (2025v3)

#### Note 1

All prices are exclusive of VAT, which must be added at the current rate (20%)

#### Note 2

Minimum job charge, (to include the EPC) is as follows:

1 dwelling (conversion) = £375 + VAT (payment in advance), or £430 + VAT (invoice)

1 dwelling (new build) = £425 + VAT (payment in advance), or £475 + VAT (invoice)

### Note 3

Minimum charge for SBEM is £595 + VAT (payment in advance) or £685 + VAT (invoice). This does not include an EPC.

### Note 4

For Air Leakage Tests - larger dwellings, or those requiring greater travelling distance, will incur a higher charge.

#### Note 5

For priority service, add 15% to the prices shown.

### Note 6

A discount can be applied to water calculation prices if these are carried out at the same time as the SAP calculations.

# Note 7

We reserve the right to make an additional charges where any of the following situations apply:

- Very large and/or complex dwellings/buildings
- New build with electric heating
- Where multiple sets of calculations (hard copy) need to be produced/distributed
- Where significantly more work/consultancy is required than usual
